Liability Release Form**

**IMPORTANT:** Each guest wishing to participate in the Cook Canyon Camp & Conference Center activities program must have a signed *Liability Release Form*. This is a legal, release of liability document. Please read and understand before signing.

I have asked to participate in the Cook Canyon Camp & Conference Center activities program and related events or have asked that my minor child participate in the Cook Canyon Camp & Conference Center activities program and related events. I understand that participation in these activities is not without risk.

**ACKNOWLEDGEMENT OF RISK, WAIVER, RELEASE AND INDEMNIFICATION**

WHILE NEW MEXICO MINISTRY NETWORK ASSEMBLIES OF GOD, INC. AND COOK CANYON CAMP & CONFERENCE CENTER MAKE EVERY EFFORT TO PROVIDE A SAFE AND PLEASANT ENVIRONMENT FOR OUR GUESTS, WE DO REQUIRE THAT THIS PARTICIPATION AGREEMENT BE READ, FILLED OUT, SIGNED AND DATED BY EACH GUEST, OR BY THE PARENT OR LEGAL GUARDIAN OF EACH CHILD UNDER 18 YEARS OF AGE, WHO WISHES TO PARTICIPATE IN THE ACTIVITIES PROGRAM AT COOK CANYON CAMP AND CONFERENCE CENTER.

The New Mexico Ministry Network of Assemblies of God, Inc. and Cook Canyon Camp & Conference Center have taken reasonable steps to provide equipment and skilled employees so our guests can participate in activities for which they may not be skilled. However, these activities are not without risk. Certain risks cannot be eliminated due to the setting and without destroying the unique character of these activities. The same elements that contribute to the character of these activities can be cause of loss and damage to your property, accidental injury or illness or, in extreme cases, permanent trauma or death. We do not want to frighten you or reduce your enthusiasm for these activities, but we do think it is important for you to be informed and know in advance about inherent risks.

I understand that no activity program is absolutely free of risk. I, on behalf of myself and my family, including minor children, agree to assume full responsibility. I expressly assume all risk and responsibility involving accidents sustained while participating in the activities program of Cook Canyon Camp & Conference Center resulting from negligence on my part, that of my family or employees, officers, directors or agents of New Mexico Ministry Network Assemblies of God, Inc. and Cook Canyon Camp & Conference Center.

I affirm that I am fully capable of participating in this activity and that my general health is good, that I do not have any condition that might endanger the life or health of myself or others participating in any activity. I affirm that I know of no reason why I should not participate.

I understand the signature of the parent or guardian of a minor child on this document shall make all provisions of this release and assumption of the risk agreement applicable to and binding on the minor child. I agree that New Mexico law shall govern this release.

I, on behalf of myself, my children, my assigns and my estate, agree to release and hold harmless New Mexico Ministry Network Assemblies of God, Inc. and Cook Canyon Camp & Conference Center, its officers, Board, agents and/or employees for any and all claims for injuries, causes of action, or liability related to participation in any activity at Canyon Camp & Conference Center.

Should New Mexico Ministry Network Assemblies of God, Inc. and/or Cook Canyon Camp & Conference Center or anyone acting on their behalf, be required to incur attorney's fees and costs to enforce this agreement, I agree to indemnify and hold New Mexico Ministry Network Assemblies of God, Inc. and Cook Canyon Camp & Conference Center harmless for all such fees and costs.

By signing this document, I acknowledge that if anyone is hurt or property damaged during my or my minor child's participation in these activities, I and/or my minor child may be found by a court of law to have waived any right to maintain a lawsuit against New Mexico Ministry Network Assemblies of God, Inc. and/or Cook Canyon Camp & Conference Center on the basis of any claim which has been released herein. I have had sufficient opportunity to read this entire document. I have read and understood it, and agree to be bound by its terms.

This liability release shall be legally binding upon heirs, my assigns, legal guardians, personal representations and myself. I have carefully read this agreement and understand its contents. I am aware that I am releasing certain rights that I otherwise may have, and I enter into this agreement on behalf of myself, minor children, and/or wards, of my own free will.
